Prevost my true and lawful attorney in fact, for me and in my name, place and stead to ask, demand, sue for, collect and receive all sums of money and demands of every description whatsoever which are or may hereafter become due, owing or payable to me from any person or persons whomsoever; to give good and sufficient receipts and acquittances therefor, and to satisfy of record any mortgages which may now or hereafter be recorded in any office in the State of South Carolina or elsewhere; hereby granting unto my said attorney full power to do everything whatsoever necessary to be done in the premises as fully as I could if personally present, though such matters might appear to require more special authority than is hereinabove specified; with full power to substitute one or more attorneys under him for the purposes aforesaid, or any of them; hereby ratifying and confirming all that my said Attorney or his substitute or substitutes may lawfully do or cause to be done by virtue hereof; and specifically ratifying and confirming all such acts heretofore performed by my said attorney, whether or not he stated in the releases above mentioned, or any of them, that he was acting as my attorney or agent.
