Westervelt, as Trustee, under and by virtue of the authority and power vested in me by the said deeds aforesaid, for and in consideration of the sum of Nine hundred and eighty (\$980.00) Dollars, to me, as Trustee, in hand paid at and before the sealing of these presents by V.M. Manning (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said V.M. Manning, All that certain lot or parcel of land situate, lying and being in Greenville Township, County and State aforesaid, near the City of Greenville, known and designated as lot No. 20 in Block "E" of the subdivision known as Augusta Court, as shown on a plat of record in the R.M.C. Office for Greenville County, South Carolina in the Plat Book "F" page 124, and having according to said plat, the following metes and bounds to-wit:

Beginning at an iron pin on the East side of Augusta Court, joint corner of Lots Nos. 19 and 20 and running thence with the joint line of said lots S. 37-57 E. 194.6 feet to an iron pin, joint corner of Lots Nos. 20 and 1; thence with the joint line of said lots, N. 52-03 E. 70 feet to an iron pin, corner of Lot No. 2; thence with the line common to Lots 2, 3 and 20, N. 37-57 W. 194.6 feet to an iron pin on the East side of Augusta Court; thence with said Augusta Court S. 52-03 W. 70 feet to the point of beginning.

Together with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining.

To have and to hold all and singular the premises before mentioned unto the said V.M. Manning, his Heirs and Assigns forever.

Nevertheless, upon the following conditions, however, which conditions are part of the consideration for this deed and are expressly for the benefit of all owners of lots as shown on said plat above referred to, to-wit:

- (1) No dwelling shall be erected nearer to the abutting sidewalk than fifty (50) feet.
- (2) The facing of the lots as shown on said plat shall be strictly adhered to, however, more than one lot may be used for the purpose of erecting a dwelling.
- (3) The property herein conveyed shall never be sold, rented or otherwise disposed of to Negroes or persons having any percentage of Negro blood.
- (4) No out-building shall be erected nearer to the abutting side-walk than fifty (50) feet.

And I do hereby bind myself, and my successors in office to warrant and forever defend all and singular the said premises unto the said V.M. Manning, his Heirs and Assigns, against myself as Trustee and my successors in office and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

Office for Greenville County, South Carolina, in Plat Book "F", page 124, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the north side of Augusta Court, joint corner of lots Nos. 12 and 13 and running thence N. 52-03 E. 190 feet to an iron pin in line of lot No. 9; thence with line of lot No. 9, N. 37-57 W. 58.7 feet to an iron pin; thence S. 55-30 W. 192.1 feet to an iron pin on Augusta Court; thence with Augusta Court S. 39-33 E. 70 feet to the point of beginning.

Boyett, her Heirs and Assigns, against myself as Trustee and my successors in office and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
