Capell, as Deacons of the East Park Baptist Church, (the receipt whereof is hereby acknowledged) have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the said F. T. Barnett R. A. Parker, W. H. Jones, A. R. Miller, W. M. Witherspoon and S. L. Capell, as Deacons of the East Park Baptist Church, all that certain piece, parcel or lot of land situate lying and being in the City of Greenville and County of Greenville, and being a portion of Boyce's Addition to Greenville and having the following metes and bounds, according to a plat thereof now recorded in the office of R. M. C. for County of Greenville, State of South Carolina, in Plat Book "A", at page 383, to-wit:

Beginning at an iron pin on the northwestern corner of lot No. 74 and the Laurens Road as shown on said plat, and running thence in a southwesterly direction with lines of Lots 74 and 75 approximately 342 feet to an iron pin on Ebaugh Ave., the northwestern corner of lot No. 75 and Ebaugh Ave., thence with Ebaugh Ave. in a northwesterly direction 25 feet, more or less, to the correct right-of-way of the C. & W. And, I, T. F. Hunt, as Trustee, do hereby bind myself, my successors, heirs, executors, and administrators, to warrant and forever defend, all and singular, the said premises, unto the said F, T. Barnett, R. A. Parker, W. H. Jones, A. R. Miller, W. M. Witherspoon, and S. L. Capell, as Deacons of the East Park Baptist Church, their successors and assigns, against myself and my heirs, s uccessors and assigns, and against every person whomsoever lawfully claiming or to claim the s ame or any part there of.
