

Whereas, on Dec. 9, 1898, H.S. Nabors and others conveyed a tract of land unto Joe Nabors for the term of his natural life and at his death to his children by his second wife, by deed recorded in R.M.C. Office for Greenville County in Book DDD, page 462, and now the said Joe Nabors having departed this life and it being desired by his children to divide the lands in kind, there being three of said children, to-wit: Frankie C. Nabors Bayne, Carrie B. Nabors Bayne and Blythe Nabors, the two first mentioned being the two referred to in the deed above named and the last mentioned being a child born after the execution of the said deed, this deed is now made for the purpose of said division:

KNOW ALL MEN BY THESE PRESENTS, That We, Frankie C. Nabors Bayne and Blythe Nabors

in the State aforesaid, in consideration of the sum of One Dollar and the premises

to us in hand paid at and before the sealing of these presents by Carrie B. Nabors Bayne

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold, and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Carrie B. Nabors Bayne: All our right, title and interest, which is an undivided

two-thirds interest, each owning an undivided one-third interest, in and to the following described tract of land, which said land is a portion of the 103 1/2 acres covered by a deed which is recorded in the office of R.M.C. for Greenville County in Book DDD, at page 462, said tract being specifically described as follows:

Beginning at a stone on Reedy River, A.G. Huff's corner and running thence S. 75 W. 17.60 chs. to stone, corner of Lot #1; thence along line of Lot #1, N. 16.50 W. 11.22 to stone, corner of Lots #s 1 & 2; thence along line of Lot #2, N. 50 W. 10.00 to stone in Harrison Bridge Road; thence along said Road N. 74.25 E. 12.40 to a Post Oak; thence further along said road S. 80.25 E. 6.70 to bend; thence S. 49.50 E. 4.74 to bend; thence N. 76 E. 6.50 to bend; thence S. 75 E. 1.80 to stone at end of Harrison's Bridge; thence down the meanderings of Reedy River as the line 13.43 chs. to the beginning corner, and containing Thirty-seven and 28/100 (37.28) acres, more or less, according to survey made by W.J. Riddle in Feb., 1924, and known as Lot #3 on a plat made by him of said survey.
