1. That certain tract of land situate on White Horse Road, in said County and State, containing Twenty-seven and 79/100 (27.79) acres, more or less, being the same tract conveyed to C.C. Hindman by J.P. Ables by deed dated January 3, 1920, recorded in office of R.M.C. for Greenville County in Vol. 66, page 251, reference being made to said deed for a more full description to said land.
