Also, all that certain lot of land situate on John Street in the City and County of Greenville, South Carolina and described in deed recorded in volume 92 page 353, less a strip at the back of said lot heretofore conveyed by me to W. B. Boyd to which deeds reference is made for accurate description of the lot hereby conveyed. I am not to accept liens that may be on said land but which the grantor herein does not assume the payment thereof.
