(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said
Eloise Sloan: All that certain piece, parcel or lot of land in the County and State aforesaid, near the City of Greenville, in the subdivision known as "Kenatamah", and situated on the south side of Oregon Street, and known as lot #8 of Block "A" on plat of the said property recorded in R.M.C. Office for said County in Plat Book "F" at pp. 66-67. The said lot has the following metes and bounds: beginning at a stake on the South side of Oregon Street, at corner of lot #7 heretofore sold to S.H. Lawton, and running thence along Oregon Street N. 63-30 E. sixty feet to stake at corner of lot #9; thence along said lot S. 26-30 E. one hundred and sixty-five feet to a stake; thence S. 63-30 W. sixty feet to stake at corner of lot #7; thence along said lot N. 26-30 W. one hundred and sixty-five feet to the beginning point on Oregon Street.

For value received, Southeastern Life Insurance Company does hereby release and forever relinquish unto the within named Eloise Sloan, her heirs and assigns, all the land herein described from the lien of two mortgages executed by F.A. Lawton, dated Nov. 17, 1920 and May 6, 1922 and recorded in Volume #33; one at page 186 being given to secure a note in the sum of twenty thousand dollars and one at page 216 to secure a note in the sum of Ten thousand dollars.

The grantee by acceptance of this deed, covenants that she will not construct on said lot any surface closet, nor toilet, but only pit or tank or such other sanitary sewers as may be provided by said grantor.
This restriction is for the benefit of the other lots in this subdivision.

AND I myself and my do hereby bind
heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said Eloise Sloan and her

heirs and assigns, against
me and my
heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
