Hanckel, All that certain piece, parcel or lot of land in the County and State aforesaid, near the City of Greenville, in the subdivision known as "Kanatelah", and situated on the north side of Oregon Street, and known as lot #5 of Block "C" on plat of the said property recorded in R.M.C. Office for said County in Plat Book F., at pp. 66 - 67. The said lot has the following metes and bounds: Beginning at a stake on north side of said Street, at corner of lot #4 of said Block, and running along said Street N. 63-30 E. Sixty feet to stake at corner of lot #6; thence along said lot N. 26-30 W. one hundred and sixty-five feet to stake at corner of lot #14; thence along said lot, S. 63-30 W. sixty feet to stake at corner of Lot #4; thence along said lot S. 26-30 E. one hundred and sixty-five feet to the beginning point on said Street.

For value received, Southeastern Life Insurance Company does hereby release and forever relinquish unto the within named W.H.
