Caughman:- "All that certain piece, parcel or lot of land in the County and State aforesaid, near the City of Greenville, in the subdivision known as "Kenatenah", and situated on the north side of Oregon Street, and known as lot #4 of Block "C" on plat of the said property recorded in R.M.C. Office for said County in Plat Book-F, at pp., 66 - 67. 130-131
The said lot has the following metes and bounds: beginning at a stake on the north side of Oregon Street, at corner of lot #3 in said block, heretofore sold to C.E. Seawright, and running thence along Oregon St., N. 63-30 E. sixty feet to stake at corner of lot #5, heretofore sold to W.H. Hanckel; thence along said lot N. 26-30 W. one hundred and sixty-five feet to a stake, corner of lot #13; thence along said lot, S. 63-30 W. sixty feet to stake, corner of lot #3; thence along said lot S. 26-30 E. one hundred and sixty-five feet to the beginning point on Oregon Street.
