In the State aforesaid, In consideration of the sum of Seven hundred DOLLARS. In hand paid to me V.T. Hardin, in the State aforesaid at and before the sealing of these presents by

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said V.T. Hardin, All that certain piece, parcel or lot of land in the County and State aforesaid, near the City of Greenville, in the subdivision known as "Kanatenah", and situated on the north side of Oregon Street and known as Lot #8 of Block "C" on the plat of the said property, recorded in R.M.C. Office for said County in Plat Book F, at pp. 66 - 67. The said lot has the following metes and bounds: Beginning at a stake on the North side of the said Oregon Street, 120 feet west of the corner of Mitchell Street, and running thence along Oregon Street S. 65-30 W. sixty feet to stake at corner of lot #7; thence along said lot, N. 26-30 W. one hundred and sixty-five feet to stake at corner of lot #17; thence along said Lot, N. 65-30 E. sixty feet to stake at corner of lot #9; thence along said Lot S. 26-30 E. one hundred and sixty-five feet to the beginning point on Oregon Street.

For value received, Southeastern Life Insurance Company does hereby release and forever relinquish unto the within named V.T. The Grantee, by acceptance of this deed, covenants that he will not construct on said lot any surface-closet nor toilet, but only septic tanks or such other sanitary sewers as may be provided by said grantee. This restriction is for the benefit of the other lots in this subdivision.

AND I myself and my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said V.T. Hardin and his

heirs and assigns, against

my Executors, Administrators heirs and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
