(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

A.F. Potter: All that certain piece, parcel or lot of land in the County and State aforesaid, near the City of Greenville, in the subdivision known as "Kananah", and known as Lot #1 in Block #1, in Block "L" on revised plat of the said property to be recorded in R.M.C. Office for said County.

The said lot has the following metes and bounds: beginning at a stake on the North side of Oregon Street at the corner of Fuller Street, and running thence along Oregon Street, 60 feet to stake at the corner of lot #2; thence along said lot, 165 feet to stake on rear line of the Lawton property; thence along said line, 60 feet to stake on said Fuller Street; thence along Fuller Street, 165 feet to the beginning corner.

For value received, Southeastern Life Insurance Company does hereby release and forever relinquish unto the within named A.F. Potter, his heirs and assigns, all the land herein described from the lien of two mortgages executed by F.A.
