Durham: All that certain piece, parcel or lot of land in the County and State aforesaid, near the City of Greenville, in the subdivision known as Kanatenah, and known as Lot #14 of Block "K" on revised plat of the said property to be recorded in R.M.C. Office for said County. The said lot has the following metes and bounds: Beginning at a stake at the corner of Lot #13, at the intersection of Cureton and Mitchell Streets, and running thence in a curve along Mitchell Street, to a stake at the corner of Lot #29; thence along lots #29 and #28, 120 feet to stake at corner of lot #13; thence along said lot, 155 feet to the beginning point.
