(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the

said J. D. Williams, all that piece, parcel or lot of land situate in Greenville County, State of South Carolina, Greenville Township, in subdivision of Suburban Land Company, known as Sans Souci Villa which lot is on the West side of Perry Road, and having the following greater and lessor, to-wit:

Beginning at an iron pin on the West side of Perry Road at corner of lot of J. D. Williams, which pin is 60 feet in the southerly direction from the intersection of Perry Road and Young Street, and running thence in a westerly direction with the line of J. D. Williams' lot 164 feet to a stake on line of land now or formerly owned by Westmoreland, which said is 60 feet in a southerly direction from the south side of Young Street, thence S. 9° 25' W. 64 feet to northerly pin on line of property belonging to Plaintiff, thence with Plaintiff's line S. 57° E. 150 feet to another pin on the West side of Perry Road, thence with Perry Road east the line N. 15° 30' E. 60 feet to the beginning corner being part of the land purchased by me from W. W. and A. S. Gallic. By deed dated May 3, 1921 and recorded in deed book Vol. 64, page 252.

Said lot as conveyed, subject to the following building restrictions which are part of the consideration of this deed and are made for the benefit and protection of the other lots shown on said plat:

(1) That no house shall be built upon this lot costing less than \$3,000.

(2) That this property nor any part thereof shall not be sold rented or otherwise disposed of to any person of African descent.

(3) That no building shall be erected nearer the street than the building line shown on the plat of the said property, said line being 25 ft. from the sidewalk.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining.  
TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said J. D. Williams, and his  
heirs and assigns, forever.
