Campbell his heirs and assigns: All that certain piece of land situate lying in Greenville Township, County and State aforesaid, near the City of Greenville, and being known and designated as Lot Number 259, see plat book "A" at pages 278-279, and having the following lines and bounds to wit: beginning at a stake on Green street 132 feet from the point at which Green street enters into McCary st. which stake is at the corner of lot no. 260, and running with line of lot no. 260 150 feet to joint corner of lots 251, 252, 259 & 260 thence with line of lot 252 66 feet to joint corner of lots 252, 253, 258 & 259, thence with line of lot no. 258, 150 feet to a stake on Green street thence with Green street 66 feet to the beginning corner!
