said J. G. Rushton: All that certain lot of land situate on Perry  
Avenue near the boundary line of the City of Greenville, known  
and designated as lot No. 6, in a plat showing subdivision  
of Haiderith-Cothran property, made by J. P. Lawrence, July  
25th, 1917, and described as follows:

Beginning at an iron pin on Perry Avenue corner of  
Lots Nos. 5 and 6; thence along Perry Avenue N. 66-30 W. 56-5  
feet to an iron pin corner of lot No. 6 and lot of H. P. Sticks;  
thence along dividing line between lot No. 6 and lot of H. P.  
Sticks N. 53-30 W. 192-3 feet to an iron pin corner lot No. 6 and  
lot of H. P. Sticks; thence with alley R. 66-30 E. 56-5 feet to  
an iron pin corner lots Nos. 5 and 6; thence along dividing  
line between lots Nos. 5 and 6 N. 23-30 E. 192-3 feet to the  
beginning corner.
