(The receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said G.B. Jordan: All those two certain pieces, parcels or lots of land in the County and State aforesaid, near the City of Greenville, in the subdivision known as "Kenatenah", and known as lots #1 of Block "F" and #9 of Block "E", on revised plat of the said property to be recorded in R.M.C. Office for said County.

The said lots have the following metes and bounds: Lot #1, Block "F": Beginning at an iron pin on the North side of Cureton Street, and running thence along said Street N. 55-56 E. 60.5 feet to a stake at corner of lot #2; thence along said lot 200 feet to stake at corner of lot #15; thence along said lot 58.4 feet to stake at line of the Lawton Property; thence along said line S. 25-51 E. 208 feet to the beginning point on said Street.

Lot No. 9, Block "E": beginning at an iron pin on the south side of Cureton Street, at the corner of an unnamed street, and running thence along Cureton Street N. 56-21 E. 60.5 feet to stake at corner of lot #10; thence along said lot 119.6 feet to stake at corner of lot #1; thence along said lot 60 feet to stake on said unnamed street; thence along said Street, 112 feet to the beginning corner.

For value received, Southeastern Life Insurance Company does hereby release and forever relinquish unto the within named G.B. Jordan and his heirs and assigns, all the land herein described from the lien of two mortgages executed by P.A. The grantee, by acceptance of this deed, covenants that he will not construct on said lot any surface closet nor toilet, but only septic tanks or such other sanitary sewers as may be provided by said grantee.

This restriction is for the benefit of the other lots in this subdivision.
