F. Loflin (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said T. F. Loflin

All that certain lot or parcel of land situate, lying and being in Greenville Township, County and State aforesaid, near the City of Greenville, known and designated as lot No. 80 of the subdivision known as Augusta Circle as shown on a plat of record in the R. M. C. Office for Greenville County, South Carolina, in the Plat Book "F," page 23, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the Western side of Tommasse Avenue, at the joint corner of lots Nos. 71 and 71, and running thence with the Western side of Tommasse Avenue S. 21.35 W. 60 feet to an iron pin; thence N. 71.35 W. 150 feet to an iron pin on the West side of lots Nos. 104 and 79, thence with the joint line of lots Nos. 79 and 104 and with the joint line of lots Nos. 70 and 102 N. 21-35 E. 60 feet to an iron pin; the joint corner of lots Nos. 80, 81, 102 and 103; thence with the joint line of lots Nos. 70 and 71, S. 71.35 E. 150 feet to the point of beginning, being all of lot No. 80 and a ten (10) ft. strip off the Northern side of lot No. 79 as shown on above plat.

- (1) No buildings shall be erected nearer to the abutting sidewalk than twenty feet, except on lots Nos. 23 to 39, inclusive.
- (2) The facing of the lots as shown on said plat shall be strictly adhered to, however more than one lot may be used for the purpose of erecting a dwelling.
- (3) The property herein conveyed shall never be sold, rented or otherwise disposed of to negroes or persons having any percentage of negro blood.

And I do hereby bind myself as Trustee, and my successors in office to warrant and forever defend all and singular the said premises unto the said T. F. Loflin, his

Heirs and Assigns, against myself as Trustee and my successors in office and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
