All that certain lot or parcel of land situate, lying and being in Greenville Township, County and State aforesaid, near the City of Greenville, known and designated as lot No. 34 of the subdivision known as Augusta Circle as shown on a plat of record in the R. M. C. Office for Greenville County, South Carolina, in the Plat Book "F," page 23, and having according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the East side of Haccamaus Avenue, the front corner of lots Nos. 34 and 35, and running thence with the front line of said lots S. 71-35 E. 166.36 feet to an iron pin in line of Haccamaus property thence with line of said property N. 51-55 E. 60 feet to an iron pin corner of lot No. 33, thence with line of that lot N. 71-35 W. 166.36 feet to an iron pin on Haccamaus Ave. thence with back corner S. 21-35 W. 50 feet to the point of beginning.

- (3) The property herein conveyed shall never be sold, rented or otherwise disposed of to negroes or persons having any percentage of negro blood.

Gamble, his Heirs and Assigns, against myself as Trustee and my successors in office and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
