to US in hand paid at and before the sealing of these presents by The Norwood National Bank of Greenville, S.C.

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

The Norwood National Bank of Greenville, S.C. All the interest now vested in us, in and to the following described premises, and such interest as we might hereafter be entitled to therein under the Will of Henry A. Cauble, and particularly the one-fourth interest devised to our mother, Bettie A. Gibson, for life:

All that certain piece, parcel or lot of land, situate, lying and being in the County and State aforesaid, in the City of Greenville, on the East side of South Main Street, and having the following metes and bounds, according to a survey and plat made by W.D. Neves, Engr., Dec. 1923, to-wit:

Beginning at an I.P. on south side of Pigtail Alley and East side of Main Street, the same being 141 feet south from the Southeast intersection of Main and Broad Streets and runs thence approximately S. 70 E. with south side of said alley 81 feet, to an I.P.; thence approximately N. 80 E. 44.5 feet to an I.P. approximately S. 70 E. 239.3 feet to an I.P., the corner of said alley and West side of Falls Street, this corner being 10 feet south of Jail Lot; thence with west side of Falls Street, approximately S. 19 W. 226.9 feet to an I.P., the N.E. corner of J.Z. Phillips lot; thence with said Phillips line and others, approximately N. 70 W. 182.5 feet to an I.P. on Tannahill & Perry Lot; thence with that line approximately N. 19 E. 102.5 feet to a post on; thence approximately N. 70 W. 178 feet to an I.P. on east side of Main Street; thence with East side of Main Street, approximately N. 19 E. 100 feet to the beginning corner.
