State of South Carolina: } Agreement to close alley.  
County of Greenville. }

Whereas, on a plat of the Stone Land Company, recorded in the R.M.C. Office for Greenville County, S.C., Plat Book "A", page 341, in Section "B", there is one block bounded by Wilton, Randall, Robinson and Croft Streets, said block consisting of lots Nos. 19, 20, 21, 22, 23, 24, 25, 26, 27, 28, 29 and 30; that lots have frontages on Croft and Randall Streets, respectively, of One hundred and eight and nine-tenths (108.9) feet with depths of Two hundred (200) feet back to a sixteen (16) foot alley, as shown on said plat; and,

Whereas, it is now the desire of all the abutting owners of lots to said alley, in said block, to close the said alley so that the depth of said enumerated lots shall be Two hundred and eight feet instead of Two hundred (200) feet, as shown on said plat; and that, with respect to Lots Nos. 25, 27 and 29, some of which have been since subdivided so that there are frontages on Wilton Street, the frontage on Wilton Street of any lot abutting on said alley shall be eight (8) feet more than any subdivision made of said lots according to the plat hereinabove referred to.

Now therefore this Agreement: That in consideration of the premises, and the benefits of additional depths or frontages to our respective lots, as above set forth, we, the undersigned abutting owners of lots of said alley, hereby consent and agree to the closing of said alley; which said alley is hereafter to remain closed.

In Witness whereof, we, the said owners of said lots have hereunto set our hands and seals this 8th day of April, 1924, hereby binding ourselves, our heirs, executors, administrators and assigns.
