Office for Greenville County, in Plat Book E, pages 35 and 36, for the purpose of laying, commecting and maintaining a pipe line or water connection with the pipe line or water main that now crosses or may hereafter be laid across Lot No. 14; and the said W.E. Rush, his heirs and assigns are hereby given the right of ingress and egress for the purpose of laying, connecting and maintaining said pipe line.

It is hereby made a condition that the said W.E. Rush, his heirs and assigns, are to lay any pipe so connected at a depth of at least 24 inches.

This memorandum of agreement made and entered into this 16th, day of April, 1924, by and between Dr. Theodore C. Stone and L.A. James, Witnesseth:

That for and in consideration of the price of Ninety-four hundred dollars, payable as hereinafter stated, Dr. Theodore C. Stone agrees to convey to L.A. James by fee simple title, with full warranty, free of encumbrance, that lot of land in the City of Greenville, South Carolina, on the north side of Earle Street, fronting one hundred feet on Earle Street, running back through the block a depth of four hundred sixteen feet to Croft Street, and having a frontage of One hundred feet on Croft Street, lying between property known as Greene Heights, and lot of Chas. B. Stone, whereon stands the old Stone Home; excepting from the lot above described so much thereof as is occupied by a portion of the Old Stone House, with sufficient land to take care of the drip of the water from the eaves of said house, L.A. James agrees to pay for the lot above described as follows, One hundred Dollars on June 1, 1924; one hundred dollars July 1, 1924; one hundred dollars August 1, 1924; one hundred dollars September 1, 1924, and the balance, Nine thousand dollars, on or before November 1, 1924.

Deferred payments shall not bear interest. Should purchaser desire to comply with this contract prior to November 1, 1924, Dr. Theodore C. Stone agrees to make deed at any time before November 1, 1924, upon tender of payment of the balance due on the purchase price. Taxes for the year 1924, shall be paid one-half by Dr. Theodore C. Stone and one-half by
