Know all men by these presents that I, Mabel C. Turner, of said County and State, in consideration of the sum of ten dollars paid to me at and before the sealing and delivery of these presents by Title Guarantee and Trust Company, a corporation duly chartered under the laws of the State of South Carolina and having its principal place of business in the City of Greenville, in said County and State (the receipt whereof is hereby acknowledged), and for divers other good and valuable considerations, have granted, bargained, sold and released, and by these presents do grent, bargain, sell and release unto the said Title Guarantee and Trust Company and its successors and assigns, all that certain piece, parcel or tract of land situate, lying and being in the State of South Carolina and County of Greenville, about two and a half miles from Greenville Court House, containing about seven and one-quarter (7-4) acres, more or less, and having the following metes and bounds according to a plat of the Looper and Yown property made by G.W.
Justice in November, 1919, from a survey made by R.E. Dalton in March 1914; said plat being now recorded in the office of the Register of Mesne Conveyances for said County and State in Plat Book "FF", at page 81, to-wit:-
