Power of Attorney.

For value received, I, L.L. Abercrombie, formerly of Simpsonville, South Carolina, but now of the County and State aforesaid, do hereby and by these presents appoint and constitute my brother W.A. Abercrombie my agent and attorney in fact with full power and authority to act for me and in my stead in winding up and closing the affairs and estate of my deceased father, Alexander Abercrombie, late of Simpsonville, South Carolina.

And the said W.A. Abercrombie is given full power and authority to sign for me and in my stead any deeds of conveyance, notes, mortgages, releases or other instruments of writing which I merely might sign, as he in his judgment may think best in connection with or appertaining to my father's estate; and it is especially intended that he shall have authority and power to convey by deed in fee simple any and all of my interest in the real estate of the said Alexander-Abercrombie.

And in giving him this authority I do hereby certify that I am unmarried. And any money coming into the hands of the said W.A. Abercrombie from a sale of any of my interests in said estate which he shall have authority in my name to do-shall be held by the said W.A. Abercrombie in trust for me and paid over by him to me as I may direct.

But his breach of this condition shall not in any way or manner avoid any of his acts hereunder as to third persons.
