Whereas, Olin Pritchett and Mrs. Carrie Pritchett, husband and wife, both citizens and residents of the County of Greenville, State of South Carolina, have been duly married and, Whereas, the said relationship as husband and wife has been mutually disagreeable and has become so disagreeable as to be intolerable and unbearable, and both parties aforesaid have become convinced that it is desirable and practicable to have a final settlement and adjustment of all property interests, rights and claims, the one against the other, growing out of said relation as husband and wife and to finally separate and cease to live together and to have any relation as husband and wife.

Now, therefore, the said parties, and especially the said Mrs. Carrie Pritchett, being fully advised of all rights, claims, and demands which she may have as such wife against her said husband, and after consultation and advice with and by her friends, relatives and attorney, and being convinced that it is to her interest to settle finally all mutual claims between her and her said husband, do hereby solemnly agree and bind themselves, their heirs, executors, administrators, and assigns, forever to the following articles of agreement and covenant:

In consideration of a tract of land being this day deeded to Mrs. Carrie Pritchett, the receipt whereof is hereby acknowledged by the said Mrs. Carrie Pritchett, she, the said Mrs. Carrie Pritchett, does hereby forever release and discharge the said Olin Pritchett, his heirs, administrators, executors and assigns from all liability, past, present and future, on account of separate alimony or maintenance and support, and she does hereby fully, freely and voluntarily in consideration of said conveyance and gift of land, release the said Olin Pritchett from all past, present or future claim of right of dower in and to any and all property, real and personal, which the said Olin Pritchett may now own or hereafter acquire, and the said Mrs. Carrie Pritchett hereby binds herself, her heirs, administrators, executors and assigns, forever to assert no claim or demand for dower in any property of the said Olin Pritchett now owned by him or hereafter to be acquired by him.

The said Mrs. Carrie Pritchett hereby agrees to take the custody of their two minor children and hereby agrees to maintain and support them from her own personal funds and to release the said Olin Pritchett from all liability for the support and maintenance of said two minor children, and the said Olin Pritchett hereby agrees not to molest or interfere with the management, control, custody, maintenance or support of said children.

The said parties, above named, hereby agree to live separate and apart, it being the purpose of this instrument and agreement to settle forever all claims and liabilities growing out of their said relation as husband and wife.

In consideration of the covenants herein expressed the said Olin Pritchett hereby releases and renounces forever any and all claims that he may have under the law, in and to the real and personal property of the said Mrs. Carrie Pritchett growing out of their marital relation, as aforesaid, or in anywise incident thereto.

The said Mrs. Carrie Pritchett further agrees not to sue or prosecute any case, civil or criminal, against the said Olin Pritchett on account of any act done prior to the signing of this agreement. To the faithful and just performance of the above articles of agreement the said Olin Pritchett-
