Whereas, Greenville Chamber of Commerce desires to erect a
building of such height as it may determine on the site
now occupied by the Record Building in Court Street, Greenv-
ille, South Carolina, and on such additional portion
of Court Street as the City of Greenville might consent to
be used for that purpose, and to that end the City of
Greenville has executed to Greenville Chamber of Commerce
a quit claim deed covering the herein after described
lot of land (which description includes the present
Record Building site); and

Whereas, The Liberty Life Insurance Company, a corporation
organized and existing under the laws of South Carolina
with its principal place of business at Greenville in said
State, as the owner of abutting property, has been requested
to execute a similar deed to Greenville Chamber of Com-
merce, and it desires to comply with said request;

Now, Therefore, Know All Men By These Presents, That The Lib-
erty Life Insurance Company, for and in consideration
of the sum of one dollar to it in hand paid at and
before the sealing of these presents by Greenville Chamber
of Commerce (the receipt whereof is hereby acknowledged)
has granted, bargained, sold and released, and by
these presents does grant, bargain, sell and release me
to the said, Greenville Chamber of Commerce all the right,
title and interest of the grantor in and to the following
described portion of Court Street, in the City of Greenville,
County and State aforesaid, to-wit:

Beginning at a point in the east side of Main Street,
which point is at the intersection of the projection of
the building line of said street and the projection
of the line of the outside of the north wall of the
Record Building, then turning an angle of ninety
(90) degrees to the left and running in an easterly
direction along the outside of the north wall of said
building and the projection of said line a distance of
one hundred and one (101) feet and ten (10) inches to
a point in Court Street, which point is thirty-one (31)
feet and two (2) inches from the outside of the south
wall of the Palmetto Building; thence turning an an-
gle of ninety (90) degrees to the right and running
through Court Street in a southerly direction forty-two
(42) feet and five (5) inches to a point in said Street;
then turning an angle of ninety (90) degrees to the right
and running along said street in a westerly direction
one hundred and one (101) feet and ten (10) inches to
a point on the projection of the building line on the east
(Over).
