at and before the sealing of these presents by W. D. Markman,

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said W. D. Markman, his Heirs and assigns forever; All of those two certain lots of land in the City of Greenville, County and State aforesaid, lying on the South side of West Washington Street, and being known as Lots Nos. 3 and 4, in plat of property of W. D. Markman, made October 1923, by G. E. Salter, Engt., and recorded in the R. R. C. Office for Greenville County, in Plat Book E, page 293, said lots being more fully described, as follows:

Lat 220. 3: Beginning at a pin on the South side of West Washington Street, at joint corner of Lots No. 3 and 4, and running thence S. 47° 47' 46.21 feet to a pin, joint corner of Lots Nos. 3 and 4, thence along line of Lot 220. 3 N. 42-30 W. 161.7 feet to pin on 15 foot alley, thence along said alley N. 46-36 W. 21 feet to joint corner of Lots Nos. 3 and 4, thence N. 42-30 E. 161.3 feet to point of beginning.

Lat 220. 4: Beginning at a pin on the South side of West Washington Street, at joint corner of Lots Nos. 4 and 5, and running thence S. 47° 44 E. 21 feet to a pin, joint corner of Lots Nos. 3 and 4, thence along line of Lot 220. 4, S. 42-30 W. 161.3 feet to pin on 15 foot alley, at joint corner of Lots Nos. 3 and 4, thence N. 46-36 W. 21 feet to joint corner of Lots Nos. 4 and 5, thence N. 42-30 E. 160.9 feet to point of beginning.

The two lots hereinabove described being the same conveyed in August, 1923, by J. G. Mauldin to the grantor herein.

The grantee herein assumes and agrees to pay a first mortgage covering lot No. 3 of \$1500.00, executed by J. G. Mauldin to Eliza A. Taylor, and a second mortgage of \$1500.00 executed by John A. Russell to J. G. Mauldin, said mortgages being recorded in Vol. 121, page 126, and 133, page 224, respectively.

The grantee herein assumes and agrees to pay also mortgages covering lot No. 4, as follows: First mortgage of \$1700.00 executed by J. G. Mauldin to Eliza A. Taylor, and second mortgage of \$1700.00 executed by John A. Russell to J. G. Mauldin, said mortgages recorded in Vol. 108, page 245, and Vol. 137, page 153, respectively.
