Frances Montgomery, all that certain piece, parcel or lot of land, situate, lying and being in Greenville Township, Greenville County, State of South Carolina, in Ward 1 of the City of Greenville on the South west corner of North Main north of said streets and being known and designated as lots Nos. 1, 2, 3, 4 and 5 on a plat prepared by G.W. Garrison, Jr. C.E. in April 1928 and recorded in R.M.C. Office for Greenville County in Plat Book 2 page 225 said lots described together, having the following width and bounds, savoir, and distances, to-wit:

Beginning at an iron pin at the southwest corner of the intersection of North Main and Efford streets and running thence with Efford street N. 67-55 W. 100 ft. to an iron pin on the east side of an 8 foot alley thence with the eastern line of said 8 foot alley S. 17-50 West 103 ft. to an iron pin on line of adjoining property thence with said line S. 61-55 E. 100 ft. to an iron pin on the west side of North Main street thence with the west side of North Main street as the line N. 19-54 E. 103 ft. to the beginning corner.
