All that certain lot or parcel of land situate, lying and being in Greenville Township, County and State aforesaid, near the City of Greenville, known and designated as lot No. 155 of the subdivision known as Augusta Circle as shown on a plat of record in the R. M. C. Office for Greenville County, South Carolina, in the Plat Book "5," page 23, and having according to said plat, the following metes and bounds, to-wit:-

Beginning at an iron pin on the South side of East Augusta Drive, at the joint corner of Lots Nos. 54 and 55, and running thence with the joint line of said lots, S. 21-35 W. 164 feet to an iron pin in the line of lot No. 53; thence with the joint line of Lots Nos. 53 and 55, N. 71-35 W. 80 feet to an iron pin, the joint corner of Lots Nos. 53, 55, 58 and 59; thence with the joint line of lots Nos. 58, 56 and 55, N. 21-35 E. 234.7 feet to an iron pin on the South side of said Augusta Drive; thence with the South side of said East Augusta Drive on a curved line of approximately S. 28-40 E. 103.7 feet to the point of beginning.

This property is conveyed subject to a Five Thousand (\$5000.00) Dollar mortgage to H. Endel, which the grantee assumes and agrees to pay in accordance with the terms thereof.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said

Nevertheless, upon the following conditions however, which conditions are part of the consideration for this deed and are expressly for the benefit of all owners of lots as shown on said plat above referred to, to-wit:

1. No buildings shall be erected nearer to the abutting sidewalk than twenty feet except on lots Nos. 23 to 39 inclusive.
  2. The facing of the lots as shown on said plat shall be strictly adhered to, however much more than one lot may be used for the purpose of creating a dwelling.
- AND the property herein conveyed shall never be sold, rented or otherwise disposed of to negroes or persons having any percentage of negro blood.
