(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

R. G. Sheck:-

All those three lots of land in the City of Greenville, County and State aforesaid, having the following meter and bounds, to-wit:

1. All that certain lot on the North side of Randall Street, beginning at a point 282 feet from the North-east corner of the intersection of Randall and Rutherford Streets, and running thence N. 1.41 E. 150 feet to corner in line of Lot 6 of Sec. A; thence S. 85.39 E. 52 1/2 feet to corner; thence S. 1.41 W. 150 feet to corner on North side of Randall Street; thence along the North side of Randall Street, N. 85.39 W. 52 1/2 feet to the beginning corner, being a part of Lot No. 6 of Section A, on part of Stone Land Company lands, which plat is recorded in the office of R.
