all of that certain lot of land, situate, lying and being in Chickasaw Township, Greenville County, State of South Carolina, near the town of Greer, on the Belham Road, having the following metes and bounds: Beginning on the said road at the corner of Lot #15 and run thence with said road S. 1.00 21.50 feet to the corner of Lot #17 thence along the line of lot #17 N. 89 21.187 feet; thence N. 1.00 E. 50 feet to the corner of lot #15; thence along the line of this lot S. 89 E. 187 feet to the beginning corner and being designated as lot #16 on a plat of the O. P. Smith property made by H. A. Christopher surveyor, May 17th 1924.
