the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said.

J. N. Norwood, his heirs and assigns: All that certain piece, parcel or lot of land situate about three miles East of the City of Greenville, in the County and State aforesaid, on the north side of the Laurens Road, with the following metes and bounds: Beginning at an iron pin at the intersection of Laurens Road and an unnamed Street and running thence with said Street N. 47.15 E. 200 feet to an iron pin; thence N. 42.45 W. 63.6 feet to iron pin at corner of lot No. 1; thence along joint line of lots Nos. 1 and 2 S. 45.15 W. 186.6 feet to iron pin on Laurens Road; thence along Laurens Road S. 30.50 E. 65 feet to the beginning corner, being known and designated as Lot No. 2 on a plat of the property of Jamison & Goodwin, said plat made by R.
