NOW, KNOW ALL MEN, That I, the said *Dannie C. Scott* as Judge of the Court of Probate as aforesaid, in consideration of the premises, and also in consideration of the sum of *899.50* Dollars,

paid me by the said *J. N. Simmons* the receipt whereof is hereby acknowledged, Have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said *J. N. Simmons* and *his* heirs and assigns forever, all that certain piece, parcel or tract of land situate,

lying and being in the State and County aforesaid, having the following metes and bounds, to-wit: Beginning at an iron pin 04, and running thence N. 73 1/4 E. 7.00 to stone, Batson's corner; thence N. 74 1/4 E. 25.30 to a stake; thence along the banks of Enoree River 61.84 ons. to a stake; thence S. 47 1/2 W. 6.44 to Hickory X3; thence S. 16 E. 4.42 to an iron pin; thence S. 33 3/4 E. 5.80 to the beginning corner, and bounded on the North by Enoree River; on the East by Enoree River and on the northwest by James Batson's land, and on the southwest by H. C. Simmons' land, and containing 41 acres, more or less.

TOGETHER with all and singular the rights, members, hereditaments and appurtenances whatsoever to the said premises belonging, or in anywise appertaining, and the reversions and the remainders, rents, issues and profits thereof; and also all the estate, right, title, interest, dower, possession, property, benefit, claim and demand whatsoever, both at law and in equity, of the said *James J.
