the receipt whereof is hereby acknowledged, Have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said  
*J. W. Quinn, Eliza G. Ballenger, & Louanna G. Bishop*  
and *their* heirs and assigns forever, all *that certain piece, parcel*  
*or lot of land described imperfectly in the Decree of*  
*the Probate Court in the Proceedings to sell this land*  
*(see Apt. 210. File 1) and more fully described by Plat*  
*made by W. A. Stester, Nov. 23-1927, and having the*  
*following metes and bounds, as per said Plat: Begin-*  
*ning at a Pin on the East side of Buncombe Road, just*  
*outside the city of Greenville, S. C. on line of Property*  
*of W. H. Taff, and running thence N. 66 1/2 E. 212 feet*  
*to a stake; thence N. 23 1/4 W. Twenty-two and one half*  
*feet to stake on line of lot of J. W. Quinn; thence S.*  
*74 W. one hundred sixty-six feet to angle; thence S.*  
*59 W. 54 feet to stake on Buncombe Road; thence with*
