NOW, KNOW ALL MEN, That I, the said *Fannie B. Scott* as Judge of the Court of Probate as aforesaid, in consideration of the premises, and also in consideration of the sum of *Five Thousand & 20/100* Dollars, paid me by the said *B. B. Bright*

the receipt whereof is hereby acknowledged, Have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said *B. B. Bright* and *his* heirs and assigns forever, all *that certain piece, parcel or tract of land situate, lying and being in the State and County aforesaid, in Highland Town-ship, and bounded by lands of W. J. Stokes, Robert Coleman, and others, and containing 55 acres more or less, and being the home place of the late S. M. Howard.*

TOGETHER with all and singular the rights, members, hereditaments and appurtenances whatsoever to the said premises belonging, or in anywise appertaining, and the reversions and the remainders, rents, issues and profits thereof; and also all the estate, right, title, interest, dower, possession, property, benefit, claim and demand whatsoever, both at law and in equity, of the said *S. M. Howard, deceased*

and of all the parties to the said suit, and of all other persons rightfully claiming or to claim the same or any part thereof, by, from or under them, or either of them. TO HAVE AND TO HOLD, the said premises with its hereditaments, privileges and appurtenances unto the said *B. B. Bright and his* Heirs and Assigns forever.
