the receipt whereof is hereby acknowledged, Have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said

Stella H. Cox

and *her* heirs and assigns forever, all *that certain tract of land in*

Butler township, State and County aforesaid, facing and abutting upon Road, and containing twenty-seven (27) acres, more or less, and bounded lands of J. H. Spearman and J. C. Jones, Mrs. Beach and B. G. Butler, and J. H. Smith.

TOGETHER with all and singular the rights, members, hereditaments and appurtenances whatsoever to the said premises belonging, or in anywise appertaining, and the reversions and the remainders, rents, issues and profits thereof; and also all the estate, right, title, interest, dower, possession, property, benefit, claim and demand whatsoever, both at law and in equity, of the said *Mary H. Cox, deceased.*

and of all the parties to the said suit, and of all other persons rightfully claiming or to claim the same or any part thereof, by, from or under them, or either of them. TO HAVE AND TO HOLD, the said premises with its hereditaments, privileges and appurtenances unto the said *Stella H. Cox, her*
