on or about the *8th* day of *June* in the year one thousand nine hundred and *thirty-four* did exhibit *their* Complaint in the Court of Probate, in the County of Greenville and State aforesaid, for the sale of the Real Estate of *J. B. Carnell, deceased* in aid of personal assets to pay debts of the deceased *J. B. Carnell*

And the cause being at issue before the Honorable the Court aforesaid, came on to be heard on the *14th*

day of *June* one thousand nine hundred and *34*, when the said Court, after a full hearing thereof and mature deliberation in the premises, Did Order, Adjudge and Decree that the real estate hereinafter mentioned and described, should be sold at public auction by the Judge of the Court of Probate for Greenville County, on the terms and for the purposes mentioned in the said Decretal Order, as by reference thereto, on file in the said Court, will appear: And the said Judge of the Court of Probate, after having duly advertised the said lands or real estate for sale by public outcry, on the *6th* day of *August* in the year of our Lord one thousand nine hundred and *thirty-four*

did then, openly and publicly and according to the custom of auctions, sell and dispose of the said real estate described below unto *P. R. Carnell and John A. Carnell* for *Two Thousand (\$2,000.00)* Dollars, being at that price the highest bidder for same.

NOW, KNOW ALL MEN, That I, the said *Guy A. Gullick* as Judge of the Court of Probate as aforesaid, in consideration of the premises, and also in consideration of the sum of *\$2000.00* Dollars,

paid me by the said *P. R. Carnell and John A. Carnell* the receipt whereof is hereby acknowledged, Have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said *P. R. Carnell and John A. Carnell* and *their* heirs and assigns forever, all *that certain piece, parcel and tract of land in County and State aforesaid in Austin Township on waters of Siders Creek and Enoree River and more fully described as follows:*

Beginning at a stake on branch and running thence N. 68 E. 16.00 to pine, thence S 27 E. 5.00 to stone, thence S 52 E. 26.80 to sweet gum on Long Branch, thence along branch to sweet gum at mouth of branch, thence along small branch 20.00 to poplar, thence N. 21 E. 20.41 to poplar, thence to beginning corner, and containing 76 acres, more or less, and adjoining lands now or formerly of A. White, Sallie White and others, and being the same lands conveyed to J. B. Carnell by J. F. Sloan by deed dated Dec 19, 1900 and recorded in Book 934, at page 820.

and of all the parties to the said suit, and of all other persons rightfully claiming or to claim the same or any part thereof, by, from or under them, or either of them. TO HAVE AND TO HOLD, the said premises with its hereditaments, privileges and appurtenances unto the said *P. R. Carnell and John A. Carnell, their* Heirs and Assigns forever.
