 Know all men by these presents, that I, May Coleman of Greenville County, in the State aforesaid for and in consideration of the benefits accruing or to accrue to me by reason of the location and construction of the State Highway over the lands hereinafter described, and for the further consideration of One Thousand dollars, paid by the South Carolina State Highway Department, in the State aforesaid, receipt whereof is hereby acknowledged, have granted, sold and released, and by these presents do grant, bargain, sell and release unto the said South Carolina State Highway Department the following described right-of-way to wit: Beginning at Disney Station 69-15 and ending at Surrent Station 103-00 from Station 69-15 to Station 84-00 a 25-foot right-of-way is required, being measured 25 feet on each side of the center line of the proposed highway, From Station 84-00 to Station 103-00 a 25-foot right-of-way is required, being measured 25 feet on the east side of center line of the proposed highway, total area of land required approximately two and eight-tenths (2.8) acres. all of these bearings or measurements being shown on the plans for Federal Aid Project 254-A on file in the offices of the State Highway Department at Columbia, South Carolina. Together with all and singular, the rights, members, hereditaments and appurtenances to the said premises, belonging or in anywise incident or appertaining, and I do hereby agree for my heirs and assigns, that the considerations herein above mentioned, and paid shall be in lieu of any and all claims to compensations and damages, by reason of the location, construction and maintenance of said road. To have and to hold all and singular the premises before mentioned unto the said South Carolina State Highway Department its successors and assigns forever. And I do hereby bind myself and my heirs, Executors and Administrators, to warrant and forever defend all and singular the said premises unto the said South Carolina State Highway Department its successors and assigns, against myself and my heirs and all others lawfully claiming or to claim the same or any part thereof.
