 pressly understood and agreed that the grantee and
 his heirs and assigns may change the location of

 to the main line of the railway. Nearly all the
 land above described was devised to the grantor
 by their father, R. Mays Cleveland Sr. as it will
 appear by his will in the office of the Court of
 Probate of Greenville County, Department 130, file
 21, said land formerly belonged to the grand father
 of the grantor James Harvey Cleveland. The lands
 include part of tract no. 1 of his home place, the
 same having been conveyed by the children of the
 said J. Harvey Cleveland to his widow, Mrs. Mary
 M. Cleveland, and subsequently conveyed to R.
 Mays Cleveland Sr. by his brothers and sisters
 May 16, 1896. See deed recorded in Book C. C. C.
 page 200, Office of Register of Deeds, Greenville.
 The lands also include a part of tract no. 2
 of said home place which was conveyed to R.
 Mays Cleveland Sr. by the same parties January
 14, 1893. See deed recorded in Book 22, page
 95-6. The above land also includes all of
 tract no. 3, of said home place which was
 conveyed to Mrs. Elizabeth M. Cleveland by the
 widow and other heirs of said J. Harvey
 Cleveland, January 14, 1893. See deed recorded
 in Book 22, page 101. The land also in-
 cludes a small portion of a tract of 78 acres
 conveyed to Mrs. Elizabeth M. Cleveland by
 B. F. and Charles Holcombe, December 3, 1884.
