Whereas, W.T. Looper and Mrs. Camilla Y. Looper heretofore executed and delivered to L.O. Patterson, as Executor of the will of John B. Marshall, deceased, their mortgage in writing, dated March 22, 1926, and recorded in the office of the Register of Mesne Conveyances for said County and State, in mortgage book 152 at page 200, covering certain lands situate in said County and State; and

Whereas, the said W.T. Looper and Mrs. Camilla Y. Looper subsequently conveyed said lands to Title Guarantee & Trust Company by a trust deed dated March 24, 1926, and recorded in said office in deed book 112, at page 190; and

Whereas, said mortgage and deed conveyed W.T. Looper's undivided one-half interest in 65.15 acres and thirteen small lots, described in general terms in paragraph five of said mortgage and deed, being the remainder of the lands conveyed to W.T. Looper and J.R. Yown by Miss Louise Earle and Mrs. India Earle McFarland by deeds recorded in said office in Book 66, at page 483 and 485, and;

Whereas, some doubt has been expressed as to which specific parcels of land were intended to be included under such general description;

Now, in order to dispel any such doubt, it is hereby agreed that the lands in which the said W.T. Looper intended to convey his half interest by said mortgage and trust deed are as follows: The 65.15 acres includes tracts numbers 40-C, 40-D, 41, 43, 46, 47, 57, 64, 65, 66, 67, 68, 69, 70, 71, 74, 75, 76, 77 as shown on plat recorded in said office in Plat Book F, page 77, and tracts numbers 45, 78, 79, 81, 82, 83, 84-A, 85, 87, 89 and 90 as shown on plat recorded in said office in Plat Book F., page 79.

The thirteen lots intended to be covered by said mortgage and trust deed are lots Nos. 93 to 105, both inclusive, shown on R.E. Dalton's plat (dated June 1924) of a re-division of Lots Nos. 1 to 27 inclusive, as shown on a plat recorded in said office in Plat Book F, page 81.
