In the Northwest side of Stall Street between Beacombs and David Streets of the City of Greenville, and designated as lot No. 18 on plat of Mountain Mt. Improvement Company and having the following width and foundation

Beginning at a point on the West side of Stall Street 115 feet from the corner of Stall and David Streets thence N. 92-3/4 W. along line of lot No 19, 121 feet to a point in lot now or formerly of W. P.
