In the White Horse Road (Washington Road) and being de-

That certain lot on the White Horse Road (Washington  
Road) and adjacent to Lot No. 3 of old Loper's Town plat  
and according to a plat of said lot, a plat  
of which is recorded in the Public Office of Greenville County  
in Plat Book No. 12 page 77 said lot is described as follows:  
Beginning at a point on the White Horse Road common  
corner of Lot 2 and a line running thence along line of Lot  
No. 2 S. 20 E. 55 feet corner of Lot 2 and a line thence N. 21-30
