containing *four* acres and *two* tenths, more or less, and *seven* tenths more particularly described as follows: Beginning at a stone in old line and running thence N. 73.45° E. 60.0' to perimeter tree; thence N. 18.3° E. 2.25' to stake; thence N. 79.30° W. 164.2' to oak wood; thence following the old course of the branch of Poplar branch S. 78° E. 275' to iron pin; thence following branch S. 20° E. 275' to iron pin; thence following branch S. 10° E. 275' to iron pin; thence following branch S. 10° E. 275' to the beginning. *Being* a portion of the land of the late W. L.
