in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said E. B. Bass

all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville, on the south side of West, Maple Street, and having the following metes and bounds, beginning at a stake 160 feet from the southeast corner of Maple and Prince Street, and running thence with Maple Street, S. 84 1/2 W. 60 feet, thence S. 44 1/2 W. 200 feet to a stake; thence S. 84 1/2 W. 60 feet back stake; thence N. 5 1/2 E. 200 feet to the beginning corner, being the same conveyed to me by Lydia M. Springs by deed dated May 26, 1925, recorded in Book 108, page 68. This conveyance is made subject to a first mortgage by S. J. G. held by Mrs. E. B. Burton and a second mortgage held by Louise M. Springs for \$2,500, recorded in Book 157, page 242, upon which certain payments have been made. This lot of land in the city of Greenville, County and State of South Carolina, being all of lot no. 11, as shown on plan of the City of Greenville, property made by C. M. Fyrmire, Feb. 17, 1921, except a foot strip cut off from the eastern side of said lot, so that the portion hereby conveyed has a frontage of 34 feet on the North side of Maple Street with a depth along the eastern side of Hartwell Avenue of 160 feet, being part of the same, conveyed to E. B. Bass by J. A. P. Davis by deed dated March 18, 1922, recorded in Book 173, page 844. There are two mortgages on this lot for \$5,000 each held by Mechanics Building and Loan Association.

The above described land is the same conveyed to me by on the day of 1927, deed recorded in office of Register of Deeds for Greenville County, in Book Page TO HAVE AND TO HOLD, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining, heirs and assigns forever.
