H. H. Ballentine, all of that tract of land situate near the City of Greenville, in the County and State aforesaid, and more particularly described as follows: Beginning at an iron pin in the former part of... 408 feet and 2 inches to iron pin in said road and in the right of way of Southern Railway Company, said railway road now used as service track; thence along said right of way S. 41.15 E. 391 feet to iron pin in said right of way; thence along said right of way S. 54.32 E. 184 feet and six inches to iron pin in said right of way and corner of the A. J. New Lot; thence along the line of that lot S. 36.47 E. 413 feet and four inches to iron pin in the New Line and Rutherford Road; thence along said road N. 55.83 E. 454 feet and five inches to the beginning corner, containing 4.62 acres, more or less.

Also, all that other tract of land situate just across said railroad from said Rutherford Road and beginning at an iron pin in the road leading from the Rutherford (concrete) Road and in the right of way of the Southern Railway and runs thence along said road N. 29.11 E. 380 feet to an iron pin in said road; thence along line of land of Southern Railway, bought by it from Pine Bluff N. 33.27 W. 393 feet and seven inches to a pin in right of way of new Southern Railway double track; thence along said right of way S. 61.15 W. 1148 feet, more or less, to iron pin in said right of way and in line of Rosa Marchbanks land; thence along new line S. 25-35 E. 203 feet and six inches to iron pin on road bank of the Osceola Road; thence crossing said road 40 feet to iron pin on opposite side of said road; thence still along Marchbanks' line S. 25-35 E. 200 feet to an iron pin; thence S. 3 W. 300 feet to iron pin in Marchbanks' and Woodside lands; thence with Woodside line S. 67-10 E. 378 feet to an iron pin in his line and right of way of Southern Railway; thence N. 65-25 E. 647 feet; thence N. 57-07 E. 363 feet; thence N. 40-15 E. 334 feet and seven inches to the beginning corner, being the same land conveyed to me by W.D. Browning by deed dated the 18th, day of September 1922, recorded Vol. 89, page 110, the said last named tract containing 35.26 acres, more or less. The road leading from the Piney Mountain Road to the Rosa Marchbanks property shall remain open unless closed by consent of abutting property owners.
