*County in book No. 2, page 254, and having accord-*  
*ing to said plat the width of said lot and having been*  
*permanently at an iron pipe on Landon Street, corner*  
*of the lot, and running thence with the rear line*  
*of the lot, S. 71-80-81-173 feet to an*
