Howard, all that certain piece parcel or lot of land situate lying and being in the City of Greenville, County of Greenville and State of South Carolina, on the South side of East Stone Avenue, and more particularly described as follows: Beginning at a stake at the rear corner of lot of *Helena S. Craskey* (about 209 feet from North Main Street, and East thereof) and running thence with East Stone Avenue S. 73 E. 55.75 feet to an iron pin thence S. 19 W. 156.4 feet to an iron pin thence N. 76.11 W. 55.7 feet to a stake in Winkle line, thence along East line of *Winkle* lot and *Helena S. Craskey* lot, 164.2 feet to the beginning corner, and being the same lot of land conveyed to me by *A. H. Howard* by deed dated February 10th 1926, and not yet recorded.*
