(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

W. D. Parrish all that certain piece, parcel or lot of land situated lying and being near the Corporate limits of the City of Greenville, in the East side of Jones Avenue, Greenville Township, State of South Carolina, and being known and designated as lot no. 6 of the W. C. Daniel subdivision as shown on Plat recorded in office of Register of Meane Conveyance for Greenville County, South Carolina, in Plat Book F, at Page 186, and having the following metes and bounds, to-wit:

to-wit: at an iron pin on the East side of Jones Avenue, front corner of lot nos. 5 and 6 and running thence with the front line of said lots S. 74° 5' 19 1/2" E. 72.7 feet to an iron pin; thence S. 11° 1' 3" E. 70.85 feet to an iron pin, corner of lot no. 7; thence with line of lot no. 7 N. 89° 20' 19 1/2" W. 195.2 feet to an iron pin on the East side of Jones Avenue; thence with said Avenue N. 1° 00' E. 70.7 feet to the Point of beginning being the same lot conveyed by W.
