(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

H. J. Martin,
That certain triangular shaped lot of land situate in Greenville Township in the County and State aforesaid, on the southwest side of the Cox Bridge Road and on the north side of the Southern Cotton Oil Company Road, and having the following meter and bounds, to-wit: Beginning at a stake in the Cox Bridge Road, which stake is the north-east corner of certain Property recently conveyed by the grantor to the grantee, and running thence along line of Property formerly conveyed to the grantee S. 34 W. 177 1/2 feet to a stake in the Southern Cotton Oil Mill Company Road, thence N. 76-26 E. along said last mentioned road 240 feet, more or less, to an iron pin at the junction of said road with the Cox Bridge Road; thence with the Cox Bridge Road N. 56 W. 162 1/2 feet, more or less, to a stake in said road, the point of beginning. The Property hereby conveyed is the eastern portion of lot no. 5 on H. C. Jones' Plat on the Samuel M. Cox Property dated September 19, 1913, the Property hereby conveyed and the Property recently conveyed by the grantor to the grantee together comprising the entire lot no. 5 on said Plat, and being a portion of the Property conveyed to the grantor by Samuel M. Cox, deceased, by deed heretofore recorded.
The fact of the consideration for this conveyance, it is agreed that the wooden storeroom situate on the Property near the junction of the Cox Bridge Road and the Southern Cotton Oil Mill Road shall remain the Property of the grantor and that she may remain in possession of same and use or collect the rent from said storeroom until the grantee, her heirs and assigns, shall desire to build on said Property, and upon written notice to such effect the grantee shall remove the said storeroom within thirty days.
It is further agreed, as part of the consideration for this conveyance, that the four room dwelling and garage which the grantee has recently built for the grantor on the adjoining Property (lot no. 6 of the above mentioned Plat) is free of all builders' mechanics' and other liens or encumbrances representing indebtedness incurred by the grantee in connection with the building of said dwelling and garage, and that no one has, claims or can rightfully claim any builder's or mechanic's lien on said dwelling and garage.
