Also all that other lot of land in said subdivision, beginning at a point 300 feet from the intersection of Hanover Street and Hanover Ave. on the East side of Cumberland Avenue and running thence S. 31 W. 20° 50 feet to corner; thence S. 31 E. 40° 150 feet to a corner; thence N. 31 E. 20° 50 feet to corner; thence N. 59 W. 40° 150 feet to the beginning, being designated as lot number 16 in Block 9 on the above named plat.
