*Mrs. Pearl Station Amick, all that lot, tracts or parcels of land, situated about 7/8 and one-half mile from the City of Greenville on north side of Spartanburg Road and in forks of said road aka road leading from it to Paris Station, Camp River, and known as the "2 corners top tract, in Cutler Township, County of Greenville, State of South Carolina, 24ishing lands of H. B. Jones, on the South, the 1/2 of the property on the west and lot no. 2 of the 1/2 estate on the north and east, and having the following metes and bounds beginning on iron pin in fork of Spartanburg road and road leading to Paris Station three rods wide to road to Paris Station 2 1/4 ft. 5.5-5, chain to iron pin on bank of road in the side, thence S. 10 E. 5.48 chains to point in corner of Spartanburg Road near South edge, thence S. 83 1/4 W. 2.56 chains to beginning corner containing two (2) acres, more or less according to survey made by J.
